Transmission due to contact between individuals and surfaces	Everyone	All archery will be conducted in accordance with the guidance issued by Archery GB and adhere with Social Distancing Guidelines.  All participants and instructors will be required to wear a face mask when delivering.  Group sizes will be up to a maximum of 15 participants, plus leaders and/or instructors.  The number of different instructors assigned to each group will be limited.  The need for guests to share equipment i.e., arrows, will be minimised.  Defined disinfecting routines will be in place to disinfect equipment i.e., bows and arrows, and contact surfaces i.e., seating area, before, after and at pre-set intervals. We will use an antiviral disinfectant that is effective against Coronavirus; certified to European standards B:2013 + A2:2019. Virucidal mist will also be used via a pump spray.  Strict maintenance of hand hygiene will be ensured. Hand sanitiser will be used before, during (where appropriate) and after a session provided by us.
